Conditions of Entry

The SAV Associate Comp will be conducted in strict accordance with the current edition (including amendments) of:

- EA Vaulting Rules 2017 (with subsequent amendments), EA General Regulations

The EA Vaulting rules may be downloaded from the EA website www.equestrian.org.au

- Competitors are advised to be aware of the Rules. The onus is on the competitors to know the rules under which they compete

Membership, Horse Registration

- Important reminder – Horses competing officially from 1st July, 2011 must be microchipped.
- All vaulters must be members of EA

Entries & Eligibility

- **Vaulters** are eligible to compete in:
 - a) Individual Horse
 - b) Squad Horse
 - c) Squad Barrel
 - d) Pas de Deux Horse
 - e) Pas de Deux Barrel
 - HC Entries will be accepted
 - Classes 7 and 13 are for Pas de Deux combinations previously scoring 6.0 or higher
Classes 8 and 14 are for Pas de Deux combinations previously scoring up to 6.0
New Pas de Deux combinations are encouraged to start in the level best suited to their ability
 - AWD classes are for vaulters with a disability; Integrated Pas de Deux and Squads must have at least one vaulter with a disability
- **Lungers:** All lungers are required to hold appropriate membership level
- **Horse points:** as per AVR
- **Arm Numbers:** Squads are to supply their own numbers. Numbers for individuals will be available for collection from the secretary's office. A refundable deposit of \$10 per number is required – a blank endorsed cheque only will be accepted.

Withdrawals & Refunds

- Refunds will only be provided after the close of entries with presentation of a medical or veterinary certificate. An administration fee may be retained by the Organising Committee.

Objections & Appeals

- As per the EA rules.

Equipment of the Vaulting Horse

- As per EA vaulting rules.

Music - Please note the following with care

All music for running in/out, compulsories and freestyles is to be submitted **no later than Monday 20th March 2017**. Please read the following information about how to submit music carefully:

1. There is only one way of **submitting music**:
 - a. All clubs / competitors must use the Dropbox www.dropbox.com. Each club to create a folder in Dropbox with all their music and invite the music person to this folder – alix_photography@outlook.com
 - b. CD's will NOT be accepted. Alternative arrangements will only be made in exceptional circumstances.
2. Each file must be clearly **labelled as follows**:
 - a. for individual competitors as follows... "Vaulters Name, Event, Class"... eg "Jessica Beattie Adv Ind Freestyle Class 3",
 - b. where the club uses compulsory music is the same for everyone as follows - QUEVA compulsories. This will be similar for the run in music also.
3. Music must be submitted in **MP3** format. The contact person will be notified if a file format is not acceptable.
4. A **final check** to ensure all the music has been received cannot be done until the final Order of Go has been distributed. Clubs / individuals are responsible for keeping their own list of what music they need and what has been sent through.
5. It is essential that all clubs / individuals **bring a copy** of all music on a flash drive u to the competition in case a file has been mislaid or corrupted during the sending process.

- Competitors must comply with any instruction given by officials at the event. Unsportsmanlike behaviour of any sort will not be tolerated from competitors or their connections.
