# Eventing Assistance Grant Guidelines

1. Clubs and Associations must be fully paid, affiliated members of Equestrian SA
2. All outstanding fees and levies are to be paid before being eligible for grant payments
3. Only official EA / FEI horse trials events are eligible for funding
4. Grant applications must be made before the conduct of the event
5. Grant applications will be assessed on a case-by-case basis. Bank fees and charges, overdrafts etc may not be claimed
6. Total grant payable per event is \$1,000 (incl GST)
7. Receipts for expenditure must be provided before grant payment can be made
8. This grant is available to support events conducted during the 2025 calendar year only
9. Funding may be granted for items that assist in the running of the event. These might include, but are not limited to:
  - Building materials for cross-country obstacles, flags, numbers, etc
  - Showjumping equipment (purchase or hire)
  - Dressage equipment (purchase or hire)
  - PA system hire
  - Hire of mowers / aerovators
  - Travel/accommodation expenses for accredited EA / FEI officials
  - Printing
10. Eventing SA maintains a set of radios, privacy screens, Spirafix ground anchors, and various MIM clip sets which are available for hire or loan to event organising committees. Use of these items is encouraged, rather than additional purchase

## Procedure

1. Complete the application (above) including an indicative budget and forward it to [eventing@equestriansa.com.au](mailto:eventing@equestriansa.com.au) for approval
2. Once approved, the Eventing SA Treasurer will contact the nominated Grant Contact regarding methods of payment to ensure this occurs promptly
