### **Expressions of Interest**

Equestrian South Australia is calling for Nominations for the EA National Show Horse Discipline Committee Delegate.

- a. To be eligible to serve on a National Discipline Committee, or Sub-Committee, a person must be a member of Equestrian Australia (EA) in a category other than Junior Member and must not be an employee of EA or one of its branches.
- b. The member will be selected for their experience and skills relevant to the work of the National Discipline Committee and should include the following:
  - i. A thorough knowledge of the discipline, including a working knowledge of EA rules and procedures,
  - ii. Administrative skills including the use of email and MS Office,
  - iii. The ability to think strategically and in the best interest of EA and the whole of the sport,
  - iv. An understanding of issues which impact on the development of the sport in Australia (or the ability to quickly acquire such knowledge),
  - v. Ability to maintain confidentiality, and
  - vi. Be reliable and punctual
- c. All members of a National Discipline Committee are required to sign a confidentiality undertaking before commencing their appointment.
- d. All members of a National Discipline Committee serve on a voluntary basis.
