# ESA Board Update to Members

# **ESA Constitution**

As members are aware the ESA Board put a draft marked-up Constitution to the membership for review and feedback. The Board considered and adopted some of that feedback and then sent a final marked-up Constitution to the membership for voting on at the 2022 AGM.

It is apparent that one of the marked-up changes has caused some discussion amongst the membership. In effect, Rule 2 of the Constitution sets out numerous purpose statements for ESA.

It is proposed that the existing Rule 2(j) be removed from the Constitution which currently reads "*at all times to act on behalf of, and in the interests of, the Members and Equestrian*". One of the reasons for the removal of this sub-rule is that it could be interpreted that ESA has to act on behalf of, and in the interest of, matters <u>outside</u> of equestrian. It should not be ESA's responsibility to act on behalf of, and in the interest of, Members of, Members outside of equestrian. ESA does not have the resources or financial capability to act for members outside of equestrian matters.

The proposed Constitution requires the Boad to act in all matters for Members pertaining to Equestrian. These statements are contained in Rule 2 and read:

- (d) represent and act for its Members in all matters pertaining to Equestrian;
- (x) represent the interests of the Members and of Equestrian generally in any appropriate forum;

(note that the underlined words are a new addition in the proposed Constitution and that (x) becomes (w) in the proposed Constitution)

It is the ESA Board's view that the above purpose statements provide the same coverage to members as (j) but limits that coverage to Equestrian matters. ESA will still act on behalf of, and in the interests of, Members in equestrian matters.

I hope this provides clarification for members on this point. If you are still unclear please do not hesitate to contact JP, at the ESA office, or myself.

It should also be noted that the Lightning Safety Protocol & the Catastrophic Fire Rating documents have been removed from the website as the information contained in these documents was out of date. These documents will now be considered as part of the Risk Register review.

Whilst all ESA policies have now been reviewed with a designated review date for each document, the ESA Board will continually review these policies.

# **Governance Review Implementation Plan**

The ESA Board continues to implement the Governance Review Implementation Plan. This plan focuses on governance policies, processes and practices. The Board is very pleased to announce that we are now nearing the completion of the plan and hope to finalise it in the coming months.
