

Dressage SA Minutes for Meeting 19.09.2022 @ 7.00 pm Meeting held at ESA Office

- 1. Welcome Meeting Opened: 7.00 pm

- 6. Discussion about correspondence from former member ESA Mary Nitschke and By-Law emails and Grant application

The chair of DSA opened the floor All members of the committee were present and able to discuss issues relating to a letter from Mary Nitschke (now a former member of ESA) and emails from Julia Weir and ESA about the membership By-Laws and a Grant application that referenced a member of ESA. It was expressed that it was unfortunate to lose one of our HP riders to NSW.

Discussion point 1- Concerns that committee members use of a signature block indicating their position on the committee on emails may be perceived to represent the views of the committee as a whole. Discussion details – JW explained Committee members are able to generate letters or emails in their capacity as ESA members or as a member of a committee or holding an office on the committee as they are able to express individual views or concerns. When emails are generated the word 'I' in the text would be sufficient to indicate that the content of the email is the opinion/view of the individual and not sent on the committee as correspondence from the committee would go through the chair position and therefore be deemed to represent the views of the committee.

Discussion point 2 – ESA Grant application – Concerns were raised by a committee member over the use of athletes names on the application when they were not based in South Australia. (Emails listed in the In and Out correspondence). Discussion details – The ORSR was contacted by JW over concerns about the performance pathways funding grant. The ORSR office (allegedly) provided a list of names that were included in the grant. JW stated that she didn't believe that ESA's Grant application was misleading on purpose but that there might have been a misunderstanding and that she was happy to hear that ORSR had received updated information from ESA amending their application. **Outcome – no further action**

Discussion point 3 - JW sent a motion to ESA on 29/8 "I would like to propose that ESA requests a review of the Membership By-Laws by EA National and that ESA supports the removal of the residency requirement for membership" JW stated that it was her individual motion to the ESA board and was not representing the DSA committee. **Outcome – no further action by DSA - to be addressed by ESA Board**
