



CALL FOR NOMINATIONS FOR ELECTED JUMPING RIDER REPRESENTATIVE POSITION

NOMINATIONS of candidates for election as Jumping South Australia (JSA) Jumping Rider Representative are hereby called.

Nominators and Nominees must be 'Competitor' level members of Equestrian South Australia Inc (ESA), at least 18 years of age and entitled to vote at ESA general meetings. They both must be current ESA members at 'Competitor' level.

Nominations of candidates for election as Jumping Rider Representative must be:

- made in writing on the form provided at **Annexure A**; and
- signed by the nominator; and
- accompanied by the written consent of the nominee; and
- completed the Nomination Resume Template.

Nominations must be made by returning a completed nomination form by no later than 4.00 pm on **Friday, 25th March 2022**.

The nomination form must be delivered to the Jumping SA Discipline Committee in any one of the following ways:

- by mail to the ESA postal address which is Unit 10 – 2 Cameron Road Mount Barker SA 5051; or
- by lodging it directly with ESA at its registered office which is located at Unit 10 – 2 Cameron Road Mount Barker SA 5051; or
- by email to Jumping SA at jumping@equestriansa.com.au

NOTES:

- Nominations are invited to fill the Jumping Rider Representative position from suitably qualified and experienced people, with the commitment and resilience to act as a conduit between the Jumping SA Committee and the South Australian Jumping riders.
- The term is for 12 months following appointment.
- Nominees and nominators must be current 'Competitor' level members of ESA.
- If multiple nominations are received an online ballot shall be conducted to determine the elected Jumping Rider Representative.
- If no nominations are received the Rider Representative position will be vacant until after the 2022 ESA Annual General Meeting
- The successful Riders Representative will become a co-opted member of the JSA Committee.

The Person – Qualification, Experience, Skills and Personal Attributes.

- Demonstrated ability to work on a committee and contribute to the strategic development of the sport and competition.
- Ability to communicate effectively at all levels.
- Respect the need for confidentiality of rider and JSA Committee matters.
- Be accountable for their actions and prepared to justify decisions.
- The Riders Representative should have an open mind and approachable personality for all Jumping competitors to raise concerns.
